The meeting was called to order at 10:10 am.

I. CHAIR'S REPORT AND INTRODUCTIONS

Chair Shayne Morgan called the meeting to order. Everyone introduced themselves and Shayne Morgan gave a brief Chair's report. Chair Morgan reported on the most recent State Emergency Response Commission Meeting. David Peaton welcomed everyone to Cedar Key and Levy County.

II. APPROVAL OF THE MAY 24, 2018 MEETING MINUETS

Action: It was moved by Ed Ward and seconded by Scott Garner to adopt the meeting minutes as presented. The motion passed unanimously

III. ELECTION OF OFFICERS

Shayne Morgan, Columbia County Emergency Management Director was re-elected as Chair. David Peaton, Assistant Director Levy County Emergency Management was re-elected as Vice-Chair, Public Information. City of Madison Fire Chief Bruce Jordan was elected as Vice-Chair,

First Responders. Gainesville Fire Rescue District Chief - Emergency Manager was appointed as the new Training Task Force representative.

IV. BUSINESS ITEMS

The Local Emergency Planning Committee reviewed the new support contract scope of work and supported the idea of a fixed fee agreement. The Committee also reviewed lists of the extremely hazardous substances contained in the region and the Section 302 facilities in each county that are included in the hazards analyses for each county.

It was reported that a U.S. Department of Transportation, Pipeline and Hazardous Materials Safety Administration Technical Assistance Grantis being used to provide three four-gas detectors and calibration kits to the following local governments: City of Gainesville, Bradford County, Columbia County, Dixie County, Gilchrist County, Hamilton County, Lafayette County, Levy County, City of Madison, Suwannee County and Taylor County.

The purpose is to increase capabilities for responding to natural gas pipeline incidents. Firefighters in each county need be able to respond to a natural gas leak and determine if an area is vulnerable to a flammable threat. Training with the Health Care Coalitions was discussed as well as how to manage chemically contaminated victims. Counties were asked to report on Hazardous Materials Incidents and Activities that have occurred in their counties.

The Annual How-to-Comply workshop will be held on November 8, 2018, in Gainesville. The Florida Department of Environmental Protection Tanks Database is being used to invite facilities that appear to have Tier 2 reporting requirements but are not reporting. This includes non-retail facilities and sites with above ground tanks of 2,000 gallons or more.

V. PUBLIC INFORMATION ISSUES

The group discussed the update of the emergency response plan and that no significant changes are included in the update this year. Next, the group discussed other public information issues including a recommendation to present hazardous materials information during hurricanes since they are not the only hazards to threaten a county. Updates were given on Tier II reporting, and that the annual update of the hazardous analyses.

The Shelter In-Place page on the Local Emergency Planning Committee webpage has been updated and is available for each county emergency agency to link to the information. The Local Emergency Planning Committee is interested in participating in three full-scale pipeline exercises to be held next year.

VI. FIRST RESPONDER ISSUES

The group reviewed the hazardous materials first responders training classes that were held during the last fiscal year. Highlights included sending individuals to the Hazardous Materials Symposium and conducting two hybrid 160-hour technician classes. Current offerings include two air monitoring classes and the first one-half of the hybrid technician class in Levy County.

How-to-Comply Workshop: Online Reporting for Facilities Regulated under the Emergency Planning and Community Right-to-Know Act (EPCRA)

The North Central Florida Local Emergency Planning Committee (LEPC) is hosting a workshop to assist facilities with using E-Plan (erplan.net) for online Tier 2 reporting. Annual chemical inventory reporting is required on hazardous materials present in amounts over 10,000 pounds for a substance that requires a Safety Data Sheet under OSHA and is not otherwise exempt.

Extremely Hazardous Substances are reportable if they are present in amounts over 500 pounds or the Threshold Planning Quantity, whichever is less. Common Extremely Hazardous Substances include sulfuric acid, chlorine, ammonia, and some restricted pesticides.

These reports must be submitted by March 1st of each year. The reports go to the State Emergency Response Commission (SERC), LEPC and local fire department. This reporting is required under law by the Emergency Planning and Community Right-to-Know Act.

How-to-Comply Workshop: Electronic Reporting of Gasoline, Diesel and Other Hazardous Materials Stored in Amounts of 10,000 Pounds or More

Florida law and the Federal Emergency Planning and Community Right-to-Know Act (EPCRA) require that a facility with 10,000 pounds or more of a hazardous material report this annually by March 1st of each year. In Florida, electronic submissions are recommended at http://erplan.net. Reporting of what is in a tank is in addition to registering the tank. You are receiving this because it appears your facility or facilities have at least one tank of 2,000 gallons or more according to Florida Department of Environmental Protection data and are not exempt from reporting requirements.

Reportable: Tier 2 reporting is on flammable and hazardous products and is in addition to any tank registrations with the Florida Department of Environmental Protection. Facilities with over 10,000 pounds of a hazardous material that requires a Safety Data Sheet under OSHA (and is not otherwise exempt) must report by March 1st of each year. The reports go to the State Emergency Response Commission (SERC), Local Emergency Planning Committee (LEPC) and local fire department. This reporting is required under both State and Federal law.

- Gasoline or diesel in <u>non-retail</u>, aboveground and/or belowground tanks with total amounts of 10,000 pounds (roughly 1,700 gallons) or more of either substance at least once during the previous calendar year.
- Gasoline or diesel in <u>aboveground</u> retail fuel tanks with total amounts of 10,000 pounds (roughly 1,700 gallons) or more of either at least once during the previous calendar year.
- The 10,000 pound reporting threshold is for total amount of gasoline and/or diesel on the entire site present at any one time, not just in one individual tank. This does not include fuels contained in personal vehicles. Gasoline (all grades combined) and Diesel amounts are calculated separately. Motor oil and used motor oil are also reportable if combined they meet the 10,000 pound reporting threshold.

Exempt: Retail gas stations with entirely underground tanks of less than 75,000 gallons total of gasoline and less than 100,000 gallons total of diesel. A retail gas station means a retail facility engaged in selling gasoline and/or diesel fuel principally to the public for motor vehicle use on land. Also exempt from reporting on a Tier 2 form is any substance to the extent it is used as part of routine agricultural operations in growing crops or raising farm animals.
